Walt Sackinsky presiding. Board members Edward Snee and Brian Lucot (via phone) were present. Also in attendance were Karen Fosbaugh, Township Manager; Chief Dennis McDonough; Aaron Laughlin, Director of Public Works; Tom Bonidie, Code Enforcement Officer; and Irv Firman, Solicitor.

Mrs. Fosbaugh stated for the record that no comments or questions were submitted.

### Call on the People

**Sarah Thor, 3615 Downing Street** – Ms. Thor inquired about the process of amending a Township ordinance relative to Hobby Farms, specifically gardening and chickens. Mr. Firman explained that a proposal to amend an ordinance would first go before the Planning Commission; and if recommended, the Board of Supervisors would hold a public hearing. Mrs. Fosbaugh suggested that Ms. Thor submit her request and comments in writing.

Danielle Strimlan, 1540 Truman Ave., - Ms. Strimlan asked about the proposed Resolution No. 7-23, regarding the Township's inclusion in the Allegheny County Community Development Block Grant (CDBG) and Home Investment Partnerships Programs. Mrs. Fosbaugh explained that the Township has participated in the CDBG Program for approximately 35 years. The Township's goal under the community development program, which is with Allegheny County through the Federal Government, has been solely restricted to Sanitary and Storm Sewers. The Township has secured hundreds of thousands of dollars in grant funding over the 35 year period, for low and moderate income areas, to improve the storm and sanitary sewers. The Township does not participate in the other components of the program. In order to continue to participate, the Township is required every three years to enact a Resolution that allows for participation.

Kmonk and Kathleen R. Kmonk (Grantors), and the Township of South Park (Grantee), the purpose of which is to abandon the recorded twelve (12') foot easement located at 3019 Decker Drive, South Park, PA 15129, being Lot/Block No. 769-N-15, which the Grantor allowed access by the Grantee to the detention pond to be owned by South Park Township for maintenance purposes,

replacing said easement with a new perpetual twenty (20') foot easement at the same address, for maintenance purposes by the Grantee, and an additional temporary twenty (20') foot Construction Easement in the same location to install a gravel driveway for access purposes; as recommended by the Township Engineer and Township Solicitor. All members voted aye. Motion carried.

Action on Assessment Change Reimbursement – Lawrence P. Action to Change Time of September Board of Supervisors Meeting Motion by Mr. Snee, seconded by Mr. Lucot, to approve changing the time of the September 11, 2023, Board of Supervisors meeting from 7:00 p.m. to 7:30 p.m. because of the annual September 11<sup>th</sup> event. All members voted aye. Motion carried.

Action on MS4 Report –July, 2023 Mrs. Fosbaugh explained that following is the MS4 report for July dated August 10, 2023. MS4 is the acronym for Municipal Separate Storm Sewer System.

- 1. The part-time litter collection employee returned from his vacation and resumed litter collection activities on Township streets to prevent trash from impacting the function of the stormwater inlets.
- 2. The Public Works Department rebuilt 6 storm sewer inlets in July.
- 3. The preapplication for CD Year 50 is being prepared. Community Development funds are used to upgrade sanitary and storm sewer lines in low to moderate income neighborhoods. South Park Township has been participating in the program for at least 35 years and has received hundreds of thousands of dollars in grant funding for these projects. The Board of Supervisors took action this evening on a resolution that indicates the Township's continued participation in the program for the next three (3) years.

- 4. The Bethel Park Municipal Authority received notice that the erosion and sedimentation control plan for the upgrades to the Piney Fork Sewage Treatment Plant was approved by the Allegheny County Conservation District and DEP.
- 5. The SHACOG flusher truck and camera was in the Township the first week of July examining and flushing problematic areas. Basins in the area of the paving program were vacuumed to reduce the amount of paving pollutants entering the fresh water supply.
- 6. South Park Township held the annual Household Hazardous Waste Collection event in the parking lot of the Public Works Department. Over 100 people participated in the event. The purpose of the collection is to offer residents an opportunity to safely dispose of chemicals, cleaning supplies, pesticides, etc. in a safe manner without introducing the materials into the freshwater system.

Motion by Mr. Snee, seconded by Mr. Lucot, to approve the MS4 Report for the month of July, 2023. All members voted aye. Motion carried.
